

In the event a sustaining fee is not made in time, a nominee may be kept eligible by making the missed payment plus a penalty fee of \$50.00 provided such missed payment and the \$50.00 penalty are paid within 20 days of the original payment deadline.

Futurity Finals and Derby finals: 1st 45%, 2nd 18%, 3rd 12%, 4th 7%, 5th 6%, 7th 4%, 8th 3%.

Horse Gate – No also/eligible horses will be allowed in the final field.

Draw dates – Monday, April 1, 2013, for trials and Monday April 15, 2013 for finals, 4:00 p.m. at race track office. 15% of purse will be deducted for administrative and advertising purposes. All added money will be paid to the horsemen. \$20.00, 2012 dues at Dixie Downs must be paid with nomination on January 1, 2013. Subject to the Utah Horse Racing commission and the St. George Lions Club Rules and Regulations. All trainers, Owners, Jockeys and Grooms must be licensed with the Utah Horse Racing Commission.
