RULES AND REGULATIONS

The undersigned represents that he/she and all persons for whom he/she is acting have read and are familiar with the Rules and Regulations of the Utah Horse Racing Commission and the Rules and Regulations of the AQHA. The undersigned also agrees to be bound by and comply with the same and with the act and decisions of the race officials. All Trainers, Owners, Jockeys and Grooms must be licensed with The Utah Horse Racing Commission.

Eligibility, Nomination and Payments

Nominations and eligibility are open to foals of 2014 which are registered with the American Quarter Horse Association. Horses registered in partnership or to any business entity shall be nominated by the authorized partner, principle officer, or owner of the business entity, or by an authorized agent. By subscription of \$150.00 (One Hundred Fifty Dollars) each which shall accompany the nomination not later than January 20, 2016 and to remain eligible by payment in accordance with schedule of payments as set forth elsewhere in this nomination blank. Nomination must also include a (1) time payment of \$25.00 to cover the 2016 Dixie Downs Dues. The St George Lion's Club reserves the right to cancel or postpone any race for any reason which it deems necessary, and all nomination and entry fees will be returned. The stalls are maintained by Washington County. The St George Lion's Club will not guarantee stall space, but will work with the county and the resident trainers to accommodate your entry.

It is the sole responsibility of the current owner to each eligible entry to make timely payments to maintain eligibility. The St George Lion's Club accepts no responsibility for providing any notice of deadlines or eligibility to any nominator or owner. Any notice provided by The St George Lion's Club is only for the convenience of the nominator or owner. Failure to mail or receive any notice shall in no way absolve the current owner from ultimate responsibility to insure timely payment. Nominations sustaining fees and late or supplemental payments will be accepted after the payment deadlines only through the United States Mail postmarked no later than midnight of the payment deadline. For all nominating, sustaining and late or supplemental payments except the trial entry fee, there will be an automatic no-penalty grace period of 48 hours in establishing acceptable postmarks. Walk-ins are also permitted within the 48 hour grace period. In case of dispute, the only satisfactory evidence of payment shall be a certified mail receipt or a registered mail receipt bearing a postmark on or before the due date. Issuance of a NSF check or stopping payment on a check tendered to cover any fee shall be absolutely prohibited.

Change of Ownership

In case of change of ownership, either the currently listed owner or the new owner of any eligible entry shall immediately notify The St. George Lion's Club of the change of ownership. Every new owner shall execute and file with The St George Lion's Club the appropriate nomination form.

Elimination Trials

Each trial shall not exceed eight (8) horses. The trial shall be raced under the same conditions as the futurity. Eight horses shall be selected from the trials to participate in the futurity. There will be no "Also Eligible" list. All horses shall be selected on a time trial basis; however, should a variable exist which would prevent this from being feasible, the stewards may then select the finalists in their order of finish in the trials. If for any reason a tie exists, the horses involved shall draw lots to determine which shall participate in the finals. In case of disqualification, the horse disqualified shall be given the time plus one thousandth of a second of the horse which he is placed behind. All qualifiers top eight will be drug tested after the trials by the track veterinarian. Horses with positive findings for zero-tolerance substances will be given a "non-time" and will not run in the finals. Additional horses may be drug tested by the track veterinarian. The decision of the stewards in all matters shall be final and entries are accepted on the condition that those person's nomination and/or starting a horse in the trials or futurity agree to abide by their decision.
